# Daily Journal Corporation User Agreement

By using the Websites, you agree to and accept the terms of this Agreement, the Privacy Policy, and any additional terms and conditions on the Websites.

#### General

You acknowledge that you do not acquire any ownership rights by downloading copyrighted material.

# **Fees and Payments**

You agree to pay all fees and charges incurred in connection with your username and password at the rates in effect when the fees and charges were incurred. For those items that are charged, the amount of the charge is displayed next to each search result. Selecting the search result to view the document will incur the charge indicated. Daily Journal may change the fees and charges at any time. All fees and charges incurred in connection with your username or password will be billed monthly by paper invoice sent to your paper subscription's delivery or billing address. If there are any annual, monthly or similar periodic fees for your subscription, these fees will be billed by invoice at the start of the annual, monthly or similar period and at the start of each renewal period, unless the subscription is terminated prior to the beginning of the next subscription period. All amounts are due not later than 30 days after the date of invoice.

#### **Online Access**

Online access is part of your Daily Journal subscription and may not be assigned to another party. Your username and password are unique to you. Sharing your username and password with any other person (including another member of your firm, company, or organization) or making it available to multiple users is prohibited.

You are responsible for maintaining the confidentiality of the username and password. You also are responsible for all activities that occur through the use of your username and password. The arbitration shall be administered by JAMS pursuant to JAMS' Streamlined Arbitration Rules and Procedures. Judgment on the Award may be entered in any court having jurisdiction. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. The parties shall maintain the confidential nature of the arbitration proceeding and the Award, including the Hearing, except as may be necessary to prepare for or conduct the arbitration hearing on the merits, or except as may be necessary in connection with a court application for a preliminary remedy, a judicial challenge to an Award or its enforcement, or unless otherwise required by law or judicial decision.

Daily Journal and you understand that, absent the mandatory arbitration provision in this section, Daily Journal and/or you would have the right to sue in court and to have a jury trial and that the right to discovery may be more limited in arbitration than it is in court. Daily Journal and you hereby waive such rights to sue in court, to a trial by jury, or to the discovery that would be available in court.

Daily Journal and you agree that Daily Journal and you will resolve any Claim on an individual basis and not on a class action, consolidated, or representative basis ("Class Action"). Daily Journal and you further agree that Daily Journal and you shall not participate in such a Class Action brought by any third party. You understand that you are hereby waiving your right to bring or participate in a Class Action related to any Claim.

### **Privacy Policy**

#### **Termination**

Daily Journal reserves the right to terminate this Agreement at any time for any reason, including, but not limited to, your failure to pay all fees and charges incurred in connection with your username and password in a timely manner or any breach by you of this Agreement.
